Privacy Policy for OG Connect

OG Connect (referred to as "we," "us," or "our") respects the privacy of its users ("user" or "you") and is committed to protecting the personal information you share with us in connection with the use of our website, services, and mobile application (collectively, the "Platform"). 1. Information Collection

- d. **Marketing:** To send you marketing emails about our services and those of our affiliates and partners, subject to your subscription preferences.

3. Sharing of Your Information

We may share your information with third parties in the following situations:

- a. **Service Providers:** With third-party service providers that perform services for us or on our behalf, including payment processing, data analysis, email delivery, hosting services, customer service, and marketing assistance.
- b. **Legal Requirements:** If required to do so by law or in response to valid requests by public authorities (e.g., a court or a government agency).
- c. **Merger or Acquisition:** In connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.

4. Data Security

We implement a variety of security measures to maintain the safety of your personal information.
